**NOTICE OF PUBLIC HEARING AND INTENT TO ADOPT A NEGATIVE DECLARATION**

**Dear Property Owner or Agency:**

This notice is being sent to property owners within or near the area shaded on the attached map and to all public agencies who are reviewing agencies for this environmental document. The map shows the property, consisting of 18.1 acres, on which Alan Shufelberger is requesting approval of Parcel Map Application PM-2018-01476 for a 21-lot industrial parcel map on property located at 3653 Rancho Road. The site is zoned "GI" General Industry District with a General Plan designation of "General Industry."

The City of Redding Planning Division has reviewed the project and, based upon the whole record before the City (including the Initial Study and any supporting documentation), is recommending that a Negative Declaration\* be adopted pursuant to the California Environmental Quality Act.

All interested persons are invited to comment in writing on the draft Negative Declaration to the Planning Division prior to the end of the public review period. The comment period for the Negative Declaration begins June 12, 2019, and ends July 2, 2019. The Board of Administrative review will consider adopting the Negative Declaration and will conduct a public hearing to consider approving the project at 2 p.m., Wednesday, July 3, 2019, River Conference Room at City Hall located at 777 Cypress Avenue, Redding, California. Adoption of the Negative Declaration will conclude the environmental review of the project.

The Initial Study, site plan, project description, draft Negative Declaration, and other information concerning the project, are available for public review from 8 a.m. to 5 p.m. weekdays at the Development Services Department, 777 Cypress Avenue, Redding, CA 96001 (telephone 530-245-7112) and online on the Planning/Projects page of the Development Services website at: [www.cityofredding.org](http://www.cityofredding.org). 
